Scheme №	Tests in accredited test laboratories and other ways of conformity proof	Check of production (quality system)	Inspection of certified products (quality system, production)	Notes

1	Type test	–	–	A test is conducted in an accredited test laboratory of the type, that is, of the type standard. This certification scheme is used for products of complex construction. Certification scheme 1 is intended for a limited volume of Russian products and imported products supplied according to the contract.
1a	Type test	Analysis of production state	–	Scheme includes a supplement to Scheme 1, analysis of the state of production.
2	Type test	–	Testing of samples, taken from the seller	A test of samples of products is conducted, then the applicant has the right to execute the certificate of conformity, this certification scheme provides for inspection control. With this purpose a sample of products is taken on trade organizations selling these goods and is tested in an accredited test laboratory.
2a	Type test	Analysis of production state	Testing of samples, taken from the seller. Analysis of production state	Scheme includes a supplement to Scheme 2, analysis of the state of production before the issuance of the certificate. Certification schemes 2 and 2a are recommended for imported products supplied on the constant basis.
3	Type test	–	Testing of samples, taken from the manufacturer	Scheme provides for tests of a sample, but without analysis of production, and, following the issuance of the certificate, inspection control by testing a sample of the products before sending them to the consumer. The sample is tested in an accredited test laboratory.
3a	Type test	Analysis of production state	Testing of samples, taken from the manufacturer. Analysis of production state	Scheme provides for mandatory tests of a sample and analysis of production, as well as inspection control in the same form as in certification scheme 3. Certification schemes 3 and 3a are applicable for products quality stability of which is observed for a long period of time.
4	Type test	–	Testing of samples, taken from the seller or manufacturer	Scheme provides for tests of the type standard, like in previous schemes, but with inspection control somewhat different from the earlier stipulated one: samples for tests are taken both from the manufacturer's warehouse and from the seller.
4a	Type test	Analysis of production state	Testing of samples, taken from the seller and manufacturer. Analysis of production state	Modified scheme in addition to Scheme 4 includes analysis of the state of production before issuance of the certificate of conformity for the products. This certification scheme is used in cases when it is unreasonable not to conduct inspection control.
5	Type test	Certification of production or quality system	Control of quality system (production). Testing of samples, taken from the seller and (or) manufacturer	Scheme is tests of a sample of products, analysis of production by certification of the quality assurance system or certification of production itself, inspection control: tests of samples of products taken from the seller and the manufacturer, and, in addition, check of stability of production conditions and the quality management system in force.

6	Consideration of the declaration of compliance with complete of documents	Certification of quality system	Control of certified quality system	Scheme provides for control at the enterprise of the quality system by a certification body, but in case the enterprise already possesses the certificate of quality system, it is enough for it to submit the application of declaration. It is usually established by the rules of certification system for homogeneous products.
7	Testing of Shipment	–	–	Scheme is tests and certification of a consignment of products. It means that a sample is taken from a consignment of products according to established rules, and it is subjected to tests in an accredited test laboratory with further procedure of issuance of the certificate of conformity. The given certification scheme does not provide for inspection control.
8	Testing of every sample	–	–	Scheme is tests of each sample of products manufactured by the enterprise in an accredited test laboratory and issuance of the certificate of conformity in case of obtaining positive test results.
9	Preliminary audit for application-declaration and attached documents	–	–	Scheme - for certification of a non-recurring consignment of a small volume of imported products released by a firm that established itself as a manufacturer of products of a high level of quality on the world or Russian markets, or for a single product, a set (complex) of products purchased as purpose-made for equipping Russian production and other facilities, in case one can make conclusions on the safety of products by means of submitted technical documents.
9a	Preliminary audit for application-declaration and attached documents	Analysis of the production (On-site inspection)	–	Scheme - for certification of products of Russian manufacturers, including individual entrepreneurs who registered their activities in the established order, at times of irregular release of products depending on the demand on market and non-expediency of conduction of inspection control
10	Preliminary audit for application-declaration and attached documents	–	Testing of samples which are obtained from producer or trader company	Certification schemes - for continuous production of Russian products in small volumes.
10a	Preliminary audit for application-declaration and attached documents	Analysis of the production (On-site inspection)	Testing of samples which are obtained from producer or trader company, Analysis of the Production (On-site inspection)
